REMARKS

1578 bags were filled with a handkerchief, an orange, and an apple. In one of the women's ward an extra orange was given to the women. (These oranges had been received on Saturday--too late to put in the bags.) Nearly all the inmates of the almshouse and the chronic wards received this treat--with the exception of some of the patients in the psychopathic building; there were not quite enough bags to go around here.

The bags were again donated to us by the Koester Bakery Company and to them we express our gratitude. Leimbach's Hardware Company again allowed us the use of their truck to haul the bags to the Hospitals and we sincerely appreciate this.

The handkerchiefs were purchased for us by Mr. John Hopf at wholesale prices. The Committee appreciates all the kindness and help which Mr. Hopf has shown to us in preparing for and carrying out this treat.

The fruit was purchased from Mr. A. A. Hofmann.

The Committee wishes to express its heartfelt appreciation to all who helped in filling and packing the bags and to all who visited the Hospitals with us and assisted in giving out the bags and who took part in the services held there. We also wish to express our appreciation to all those who gave us donations of money with which to purchase oranges and to all those who brought oranges to the hall. The money has been turned over to the Financial Secretary--amount \$7.50.

We feel sure that this treat has indeed brought cheer and happiness to many who have but little to brighten and cheer their days. We saw many expressions of such happiness Saturday which more than makes up for the time, planning, and work spent on ~~sueh~~ a task. Although where there are so many there is bound to be some duplication of gifts and where there are some people who will take more than their rightful share, we still feel that the treat was very worth-while and did bring happiness to so many.

All bills have been turned over to the Financial Secretary for payment.

The question of inaugurating an early Sunday

morning english service for the summer months was raised because several members had requested it. After much discussion, in order to bring it before the members for action, a motion was made by Mr Metzger and seconded by Mr Fred Schuefel that the services be held from 6:30 to 7:30 A.M. After more discussion as to the time, Mt George Trautner left the chair in order to talk on the question and proceeded to offer an amendment to the motion changing the time to 6 to 7 A.M., where-upon Mr. Metzger with the consent of Mr. Schuefel withdrew his motion. This left the procedure open to Mr. Trautner who made a motion to hold our english services from 6 to 7 A.M., and seconded by Mr. Adam Trautner. More discussion followed and finally the following schedule was adopted.

- (c) 1. They shall interview the candidates, secure their consent to serve and then report their selections to the congregation at its annual meeting in December. The persons so selected by the Committee shall be deemed to be the final choice of the congregation.
